- (e) Purpose for which the land granted may be used: **RESIDENTIAL**

- (b) To keep the exterior and interior of the buildings to be erected and the outbuilding and erections which may at any time during the term hereby created be erected on the land hereby granted and all additions to such buildings and outbuildings and the walls, fences and appurtenances thereof in good and tenantable repair and condition.

- (i) To install and operate water borne sewage system within six months from the date the buildings erected on the plot are connected to piped water-supply.

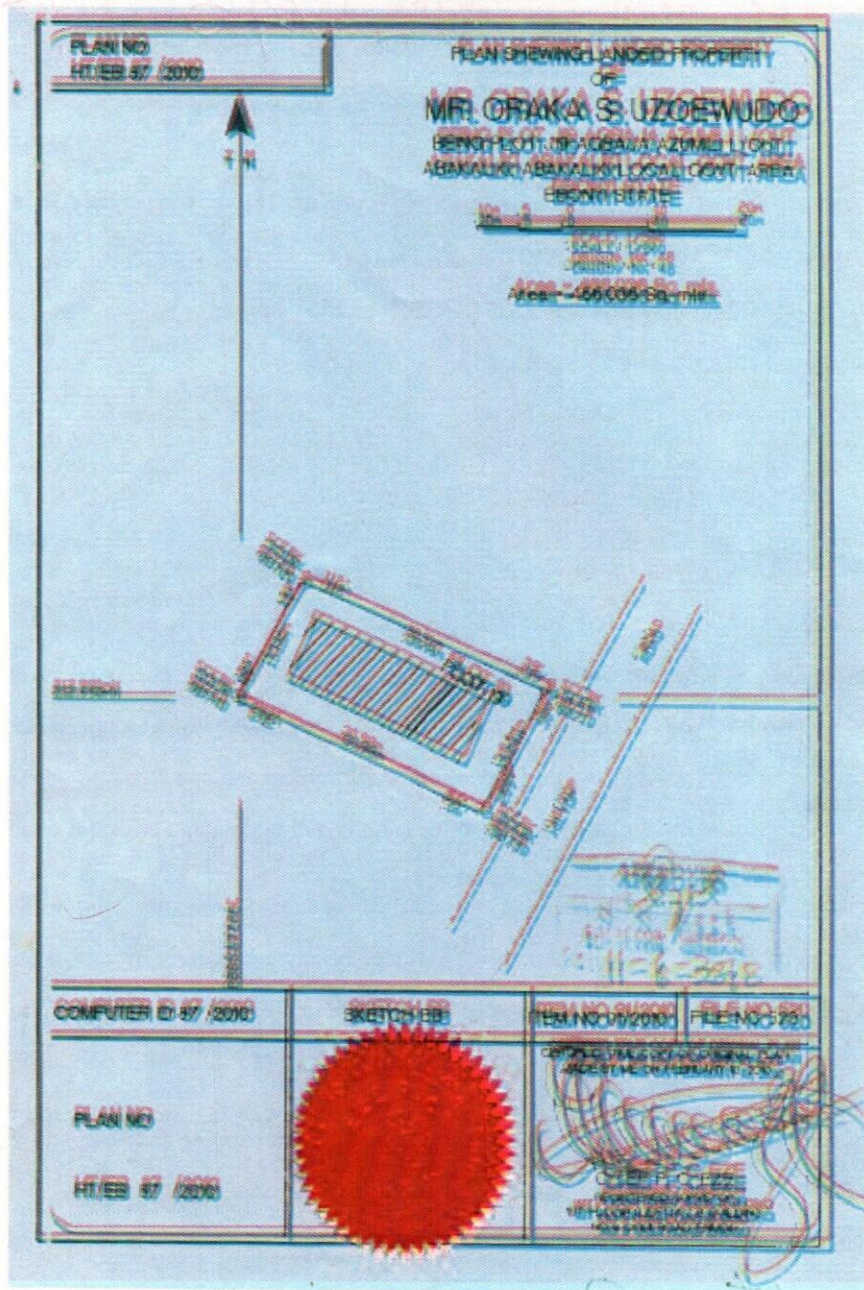
